Endorsement by the Board of Directors and the Managing Director

The Depositors' and Investors' Guarantee Fund was established on December 28, 1999. According to the fund's Article of Association, it is operated by two departments with separate finance and accounting, depositors' department and investors' departments. The fund may also operate a special credit department.

During establishment, the fund took over assets and liabilities of the Commercial Banks' Guarantee Fund and the depositors' department of the Savings Banks' Guarantee Fund. According to law no. 98/1999 applicable to the fund, total assets of the depositors' department may not be lower than 1.0% of average insured deposits of commercial banks and savings banks the previous year but the fund did not meet with this requirement at year-end 2006. It is assumed that approx ISK 1,316 million need to be collected with commercial banks and savings banks in order to reach the legal minimum size of the fund in addition to issuing a guarantee pledge to the amount of 657 million.

The fund's investment policy states essentially that proportion of government bonds may not be lower than 70% of the assets in management, applying to both domestic and foreign government bonds. Minimum proportion of domestic government guaranteed bonds shall not be lower than 30%. Combination of assets was within this authorized limit a year-end. In the year 2006, ISK 14 million were collected due to the investors' department. According to provisions on the investors' department in the aforementioned law, the department's total assets shall amount to at least ISK 100 million. At year-end, the department's equity amounted to approx ISK 114 million. No decision has been made whether a credit department will be established.

Independent Auditor's Report

To the Board of Directors of The Debpositors' and Investors' Guarantee Fund.

Introduction

We have audited the accompanying Financial Statements of The Depositors' and Investors' Guarantee Fund for the year 2006, which comprise the Endorsement by the Board of Directors, a Balance Sheet, an Income Statement, and a summary of significant accounting policies and other explanatory notes.

Management's Responsibility for the Financial Statements

Management is responsible for the preparation and fair presentation of these Financial Statements in accordance with the Financial Statements Act. This responsibility includes: designing, implementing and maintaining internal control relevant to the preparation and fair presentation of Financial Statements that are free from material misstatements, whether due to fraud or error; selecting and applying appropriate accounting policies; and making accounting estimates that are reasonable in the circumstances.

Auditor's Responsibility

Our responsibility is to express an opinion on these Financial Statements based on our audit. We conducted our audit in accordance with International Standards on Auditing. Those standards require that we comply with relevant ethical requirements and plan and perform the audit to obtain reasonable assurance whether the Financial Statements are free from material misstatement.

An audit involves performing procedures to obtain audit evidence about the amounts and disclosures in the Financial Statements. The procedures selected depend on our judgement, including the assessment of the risks of material misstatement of the Financial Statements, whether due to fraud or error. In making those risk assessments, we consider internal control relevant to the entity's preparation and fair presentation of the Financial Statements in order to design audit procedures that are appropriate in the circumstances, but not for the purpose of expressing an opinion on the effectiveness of the entity's internal control. An audit also includes evaluating the appropriateness of accounting policies used and the reasonableness of accounting estimates made by management, as well as evaluating the overall presentation of the Financial Statements.

Fees due to asset management of securities holding of the depositors' department during the year amount to a total of ISK 56 million, whereof transaction fees amounted to ISK 40 million but performance based fees and fixed management fees amounted to ISK 16 million. Transaction fees are entered to the reduction of interest income, indexation and foreign exchange difference but performance based fees and fixed management fees are entered as a specific item among expenses.

It is therefore assumed that the fund must collect approx. ISK 1,316 million in the year 2007 from commercial banks and savings banks in order to reach the legal minimum size of the fund and in addition, the fund must issue guarantee pledge to the amount of ISK 657 million.

Obligation due to bankruptcy of a member company

6. At the end of November 2001, one of the member companies of the fund, Burnham International in Iceland hf., was declared bankrupt. The insolvent's state is still under liquidation proceeding and it is unclear when the liquidation will be finalized. A claim to the amount of ISK 226.5 million was made to the investors department of the Fund. A part of the claim was revoked and a payment obligation due to a greater part of other claims was rejected while remaining claim amounts to ISK 57 million, including interests, but the total charge of the year is the equivalent to accrued interests on principal. It must be considered likely that the investors' department of the Fund will incur expenses due to the company's bankruptcy.
